



Grupo Televisa informs

Mexico City, October 30, 2025 – Grupo Televisa, S.A.B. (“Televisa” or the “Company”; NYSE:TV; BMV:TLEVISA CPO) announced that, Mr. Eduardo Tricio Haro, member of the Company’s Board of Directors, informed the Company today, in compliance with Article 110 of the Securities Market Law (*Ley del Mercado de Valores*), that he has acquired securities representing approximately 7.2% of the capital stock of the Company. Mr. Tricio also informed the Company that he has no intention to acquire a “significant influence” (*influencia significativa*) over the Company.

In relation to the unusual movements in the trading volume of its securities identified with the ticker TLEVISA CPO, presented today, the Company informs that it is not aware of the reasons that may have caused these movements.

Furthermore, except for the aforementioned, the Company informs that it is not aware of any transactions involving the Company’s shareholders, directors, relevant officers, or the Company itself, through its share repurchase program, that may have caused these unusual movements.

This communication is made at the request of the Mexican Stock Exchange, based on the provisions of Article 106 of the Securities Market Law (*Ley del Mercado de Valores*) and Article 50, last paragraph, of the General Provisions applicable to issuers of securities and to other participants of the stock market (*Disposiciones de carácter general aplicables a las emisoras de valores y a otros participantes del mercado de valores*).

In addition, Televisa is the largest shareholder of TelevisaUnivision, a leading media company producing, creating, and distributing Spanish-speaking content through several broadcast channels in Mexico, the US and over 50 countries through television networks, cable operators and over-the-top or "OTT" services.
